Urge government to take 3 important actions:

- 1** End predator control programs in Alberta & BC. This practice is ethically unacceptable, outdated, and ineffective, especially when critical habitat is still being destroyed and fragmented where threatened species live.
- 2** Institute hunting regulations for wolves in each province that i) require a specific seal to hunt wolves, ii) shorten season lengths, iii) create bag limits, iv) implement mandatory reporting of all wolves killed so that accurate records and monitoring can be established. Current regulations are outdated & do not reflect modern understanding of the role wolves play as a keystone species within ecosystems nor their intrinsic values as a social and intelligent mammal.
- 3** Support legislation for buffer zones around National Parks in the Central Rockies. Current protected areas are too small to adequately protect wolf populations as they would naturally occur. Buffer Zones around Algonquin Provincial Park in Ontario have proven successful at maintaining intact wolf families.
